

Dakota Arena Ice Rentals Terms and Conditions (revised 7/9/20)

- 1) Enter Sportsplex main entrance. Players will be permitted access to dressing rooms no earlier than 15 min before scheduled ice time. Early arrivals will be asked to wait outside.
- 2) DCC rep will meet individuals as they arrive to ask screening questions, provide directions and review terms and conditions with participants.
- 3) Guests must sanitize hands before proceeding.
- 4) Participants must practice social distancing in dressing rooms (limit 7 per room). Additional seating may be available outside the dressing rooms. Teams/groups are encouraged to come at least partially dressed so that players require minimal time in the dressing rooms.
- 5) Renter group leaders (i.e. coaches, instructors) are expected to ensure participants follow guidelines set out by governing sport bodies (i.e. Skate MB, Hockey MB), the Province of MB (social distancing, personal hygiene) and DCC (regarding facility use).
- 6) It is the responsibility of the renter groups to be familiar with all provincial regulations, DCC guidelines and accepts any and all risks associated with using DCC facilities. Renters to provide their staff with necessary PPE.
- 7) Any renter groups found to be in violation of provincial regulations resulting in fines will be responsible for payment of the fine.
- 8) Groups have 15 min to vacate dressing rooms to allow staff to clean rooms before the next group arrives.
- 9) Exit down hall and through Sportsplex main entrance.
- 10) Renter groups are limited to using locker room washroom facilities. Two shower heads are permitted. The middle shower will be unavailable to promote physical distancing.
- 11) Use of concession area tables are not permitted.
- 12) Use of rink benches/boxes is permitted.
- 13) Participants are encouraged to come dressed, needing to only put on skates/helmets
- 14) Participants are encouraged to bring their own prefilled water bottles and not share with other participants.
- 15) Up to two spectators per player are permitted into the facility at this time with the following conditions.
 - a. It is encouraged the parents continue to drop off and wait outside the facility while they change. Parents may come in just before the start of practice/game and must leave the facility immediately after and wait for players outside.
 - b. All spectators must sanitize hands and answer screening questions. Phone numbers must be provided in the event contact tracing is necessary. All information will be kept confidential.
 - c. Spectators are confined to bleachers and must practice social distancing. The concession area seating and other designated areas will remain off limits.
 - d. Parents may be permitted to assist children age 10 and under with equipment as needed but must leave the facility immediately when done and wait outside the facility until the start of the practice/game.
 - e. Must enter and exit the arena area via the dressing room hallway and follow directional arrows.
 - f. Stay within designated areas with the bleachers only and practice physical distancing with anyone outside their social "bubble".
